

2018 AAA Northeast Insider Trip to Universal Orlando Sweepstakes Official Rules

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. MEMBERSHIP IN THE INSIDER PROGRAM IS NOT REQUIRED FOR ENTRY INTO SWEEPSTAKES. VOID WHERE PROHIBITED.

1. ELIGIBILITY: Open only to legal U.S. residents of Connecticut, Massachusetts, New Hampshire, New Jersey, New York or Rhode Island who are thirteen (13) years of age or older as of date of entry. Employees of AAA Northeast ("Sponsor"), Universal City Development Partners, Ltd. d/b/a Universal Orlando ("Prize Provider"), Compliance Sweepstakes Services, LLC ("Administrator") (collectively, the "Released Parties"), and its and their affiliates, divisions, subsidiaries, and all coordinating agencies or entities for the "2018 AAA Northeast Insider Trip to Universal Orlando Sweepstakes" (the "Sweepstakes") and the immediate family members (defined as spouse, parents, grandparents, children, grandchildren, siblings, - whether biological, adopted, step or in-law) of such individuals, or persons living in the same household as such individuals (whether related or not), are not eligible to participate in the Sweepstakes. Sweepstakes is governed by U.S. laws and is subject to all applicable federal, state and local laws. Void outside the U.S., void in all states other than Connecticut, Massachusetts, New Hampshire, New Jersey, New York and Rhode Island, and void where prohibited, taxed or restricted. By participating in the Sweepstakes, participants agree to be bound by these Official Rules and the decisions of the Sponsor and Administrator, which shall be final and binding in all respects.

2. HOW TO ENTER: Sweepstakes begins at 12:01 am ET on January 1, 2018, and ends at 11:59pm ET on April 30, 2018 (the "Promotion Period"). An individual will be deemed a participant (the "Participant") in the Sweepstakes if he/she is eligible, and enters in any of the following five (5) methods: 1) **JOIN INSIDER TO ENTER:** Any person who becomes an Insider during the Sweepstakes Promotion Period will automatically be entered for a chance to win. This entry method is open only to Participants that are current AAA members; 2) **ENTER AT AAA NORTHEAST BRANCH OFFICE:** Entry Forms are available between January 1, 2018 and April 30, 2018 at any AAA Northeast branch office in Connecticut, Massachusetts, New Hampshire, New Jersey, New York and Rhode Island. Participant must complete the Entry Form in its entirety and deposit in the Entry Box at the branch office. Entry Forms accepted until close-of-business on April 30, 2018 at AAA Northeast branch offices in Connecticut, Massachusetts, New Hampshire, New Jersey, New York and Rhode Island. No photocopied, facsimile, or mechanically reproduced Entry Forms permitted; 3) **ENTER AT THE AAA TRAVEL MARKETPLACE EVENTS:** Entry Forms are available between March 3, 2018 and March 5, 2018 at the AAA Travel Marketplace event located at Gillette Stadium, Foxborough, Massachusetts and between March 10, 2018 and March 12, 2018 at the AAA Travel Marketplace event located at Hofstra University Sports & Exhibition Arena on Hempsted Turnpike, Hempsted, New York. Participants must complete the Entry Form in its entirety and deposit in the Entry Boxes at the respective event. Entry Forms accepted until the close of the events on March 5, 2018 and March 12, 2018, respectively. No photocopied, facsimile, or mechanically reproduced Entry Forms permitted; 4) **ENTER ONLINE:** During the Promotion Period, Participants may enter online by visiting the following URL address: www.AAA.com/Insider. Clicking on the Sweepstakes icon will redirect the Participants to a specific URL address to access the Sweepstakes. At the Sweepstakes site, each Participant must fully complete the required fields on the sweepstakes registration form in order to enter the Sweepstakes. Use of any automated entry software is prohibited. In the event of a dispute regarding the identity of any potential winner, the potential winner will be deemed to be the authorized account holder of the email address submitted at the time of Sweepstakes entry. The authorized account holder is defined as the natural person who is assigned an email address by an Internet access provider, online service provider or other organization that is responsible for assigning email addresses or the domain associated with the submitted email address; 5) **ENTER BY MAIL:** Participants may enter by mailing a 3" x 5" index card containing the first and last name, home address, email address, home/cell phone numbers and date-of-birth of entrant to AAA Northeast Insider Trip to Universal Orlando Sweepstakes, 110 Royal Little Drive, Providence, RI 02904. Fully completed mailed-in entry forms must be submitted by US Mail at the above address and must be postmarked no later than April 30, 2018 and received by May 5, 2018. A valid entry submitted and received via any of the aforementioned five (5) methods of entry will earn one (1) Sweepstakes entry. Sponsor is not responsible for incomplete, ineligible, illegible, lost, late, stolen, damaged, postage-due or destroyed entries. Sponsor is not responsible for technical, hardware or software failures of any kind, lost or unavailable network connections or failed, incomplete, garbled or delayed software transmissions which may limit an entrant's ability to participate in the Sweepstakes or damage to the user's system as a result of participation in the Sweepstakes or downloading any information necessary to participate in the Sweepstakes. All entries become the property of the Sponsor and will not be acknowledged or returned. False or deceptive entries or acts, as determined by Sponsor in its sole discretion, will render the entrant ineligible. Limit one (1) entry per person, regardless of means of entry.

3. PRIZE & APPROXIMATE RETAIL VALUE: One (1) Grand Prize: Trip for up to four (4) people (one of whom must be the Grand Prize Winner, and all of whom must travel on the same itinerary) to Universal Orlando® Resort in Orlando FL. Prize package consists exclusively of: Roundtrip coach class airfare with carrier selected by Prize Provider for up to four (4) people between Boston Logan International Airport in Boston, MA or T.F. Green Airport in Providence, RI or Manchester Boston Regional Airport in Manchester, NH or Bradley International Airport in Windsor Locks, CT or John F. Kennedy International Airport in New York, NY or LaGuardia Airport in New York, NY or Syracuse Hancock International Airport in Syracuse, NY or Stewart International Airport in Newburgh, NY or Cooperstown-Westville Airport in Cooperstown, NY (departure airports) and Orlando FL; non-exclusive ground transportation to/from Orlando International Airport to Universal Orlando Resort® for up to four (4) people (Winner will be responsible for ground transportation to/from the airport at point of origin); four (4) consecutive nights lodging (includes room and tax only) for up to four (4) people in a maximum of one (1) standard or garden view room at an on-site hotel at Universal Orlando® Resort, as selected by Prize Provider (Hotel accommodations do not include meals, incidentals, tips, telephone calls, or any other personal expenses incurred during the trip, not specified here); and Complimentary theme park admission with Universal Express access for winner and up to three (3) guests to Universal Studios Florida and Universal's Islands of Adventure theme parks and Universal's Volcano Bay water theme park for four (4) consecutive days including a non-exclusive VIP Experience of Universal Studios Florida® and Universal's Islands of Adventure® for one (1) day; and an Universal Dining Plan for four (4) consecutive days for four (4) people. Travel must be completed no later than December 31, 2018 or prize will be forfeited. Blackout dates or other restrictions may apply as dictated by airline and/or hotel. Winner's travel arrangements must be made a minimum of sixty (60) days prior to Winner's travel and are subject to availability. If Winner is unable to redeem prize during time period, Winner forfeits the prize package. The Released Parties shall have no responsibility or liability for cancellations and/or delays or any change by the air carrier(s), lodging facilities, entertainment, or other company or any other persons providing any of components of the prizes for the Grand Prize Winner and his/her guests due to reasons beyond the Released Parties' control. All elements of the prize must be redeemed at the same time, and no changes will be permitted after confirmation of any redemption. If Winner elects to partake in any or all portions of his/her prize with fewer than the above stated number of guests or no guest, the prize will be awarded to Winner and each participating guest and any remainder of the prize will be forfeited and shall not be subject to further or alternative compensation. If the winner is between the ages of thirteen (13) and the age of majority in his/her state of residence, the winner's parent or legal guardian must accept the Grand Prize Package on their behalf. If the winner (or winner's parent or legal guardian) is between the ages of eighteen (18) and twenty-one (21), he/she must be accompanied by an adult, who is at least twenty-one (21) years of age, in order to check in to on-site hotel. All unclaimed and/or unused prize packages, will remain the property of Universal Orlando and may not be sold, exchanged or otherwise transferred by Winner. Winner and guests must travel at the same time and must depart from the same city. All details of the Grand Prize Package will be determined by Universal Orlando in its sole discretion and Universal Orlando reserves the right to substitute a similar prize or prize element of comparable value. All the tickets are valid during normal operating hours only. Operating hours and availability of attractions and shows are subject to change without notice. Some special events may be separately ticketed. Universal reserves the right to change the name of all tickets. All tickets specifically exclude admission to special or separately ticketed "hard ticket" entertainment events at either of the theme parks, hotels, or within any of the Universal CityWalk venues such as Hard Rock Live® and the Blue Man Group show. Lodging does not include meals, incidentals, tips, telephone calls or any other personal expenses incurred during the trip, not specified here. Actual value of prize may vary based on timing. Approximate Fair Market Value ("AFMV") of the Grand Prize Package is \$6,891.00. Total Prize Pool - \$6,891.00

4. RANDOM DRAWING & CERTAIN RESTRICTIONS: One (1) Grand Prize Winner will be selected via random drawing from among all valid entries received during the Promotion Period or otherwise postmarked as provided in these Rules. A random drawing will be conducted on or around May 10, 2018 by the Administrator, an independent judging organization, whose decisions will be final and binding with respect to all aspects of the Sweepstakes. Odds of winning depend on the number of eligible entries received in accordance with these Rules. Grand Prize Winner will be notified by telephone, e-mail or telephone within five (5) business days of the random drawing. Grand Prize Winner and traveling companions (or traveling companions' parent or legal guardian if under 18) will be required to sign an Affidavit of Eligibility/Release of Liability/Consent to Use/Prize Acceptance Form/Publicity and Advertising Consent and Release (except where prohibited by law) which will include a Release of Prize Provider, and such other documents reasonably required by Sponsor in connection with Sponsor's use of Winners' name, likeness, and biographical information without compensation prior to accepting the Prize. In addition, Grand Prize Winner will be required to submit any other legal documents which Sponsor may require (including identification verification document in the form of a driver license, passport, or birth certificate; and a W-9 tax form), unless prohibited by law, prior to accepting the Prize. All such documents must be signed and returned within fourteen (14) days of prize notification. Noncompliance within this time period may result in disqualification. Return of the prize or prize notification as undeliverable, failure of Sponsor to contact Winner based on contact information provided at registration, or failure of potential Winner to respond to notification attempts will result in disqualification and an alternate may be selected at the Sponsor's discretion. Grand Prize Winner will be issued a tax form 1099 for the AFMV of the prize. In the event of sabotage, acts of God, computer virus or other events or causes beyond the Sponsors' reasonable control which corrupt the integrity, administration, security or proper operation of the Sweepstakes, Sponsor reserves the right to terminate or suspend the Sweepstakes. In the event of termination, prize will be awarded from among all eligible, non-suspect entries received prior to the event requiring such cancellation. The Grand Prize Winner is responsible for all travel documentation and must complete the prize trip by December 31, 2018 or otherwise forfeit any claim to such prize package, and neither Sponsor nor Prize Provider will have any further obligation to Winner. Winner will receive a prize letter from Sponsor. All elements of the Grand Prize must be booked and redeemed at the same time and no changes will be permitted after confirmation. Trips are non-transferable and have no cash value.

5. USE OF PERSONAL INFORMATION/OPT IN: By entering the Sweepstakes, you consent for the Sponsor to obtain, use, and transfer your name, address and other information ("Personal Information") for the purpose of administering this Sweepstakes and such Personal Information will be kept by Sponsor for marketing purposes. The information that you provide in connection with the entry process will be used by Sponsor and Administrator only, and will not be sold or provided to another company. You will remain eligible for this Sweepstakes whether or not you opt in to receive promotional e-mails from the Sponsor and will have the ability to opt out of receiving future promotional e-mails by clicking on the link contained in the most recent promotional e-mail received.

6. RELEASES: All Participants, as a condition of participation or entering in this Sweepstakes, agree to defend, indemnify, release and hold harmless Sponsor, Prize Provider, Administrator, its affiliates, and the officers, directors, and employees, and Released Parties from and against any and all liability, claims, damages, injuries or actions of any kind whatsoever for injuries, damages, or losses to persons or property which may be sustained in connection with: (a) accessing the Sponsor's Web Site; (b) participating in any aspect of the Sweepstakes, including, without limitation, while preparing for, participating in and/or traveling to or from any prize or Sweepstakes-related activity, including, without limitation, any injury, damage, death, loss or accident to person or property; (c) the receipt, ownership, possession, use or misuse of any prize awarded; (d) viruses or any downloading or other problems with the Sweepstakes application; or (e) any typographical, printing, or other error in these Official Rules, advertisements, or the announcement of offering of any prize. Prize winner bears all liability and risk of loss to his/her respective prize after it has been delivered. In the event that any provision of the Official Rules is determined to be invalid or otherwise unenforceable or illegal, the other provisions will remain in effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. Sponsor's failure to enforce any term of these Official Rules will not constitute a waiver of that provision.

7. GOVERNING LAW/DISPUTES: By participating, Participants agree to be bound by the Official Rules, Sponsor's Web Site Terms of Use, and the decisions of the Sponsor and Administrator, which are final and binding in all respects. Except where prohibited, Participant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and any judicial proceeding shall take place in a federal or state court in Providence, Rhode Island; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event legal fees; and (3) under no circumstances may entrant obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the Participants, Sponsor, or the Released Parties in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of Rhode Island without giving effect to any choice of law or conflict of law rules (whether of the State of Rhode Island or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Rhode Island.
